

PROJECTSAM TRUE STRIKE PRODUCT LICENSE AGREEMENT

By installing the TRUE STRIKE (KONTAKT PLAYER RE-RELEASE EDITION) LIBRARY CONTENT you accept the following product license agreement:

1a. LICENSE GRANT: COMMERCIAL LICENSE

This paragraph applies to users who purchased a commercial license for this product.

The license to use this product is granted to a single user only. All sounds and samples in this product are licensed, not sold, to you by ProjectSAM, for COMMERCIAL USE in music production, public performance, broadcast or similar use. ProjectSAM allows you to use any of the sounds and samples in commercial recordings without paying any additional license fees. One commercial license allows you to install and activate this product on a MAXIMUM OF 2 (TWO) computer systems or samplers, as long as you are the sole user of these systems or samplers.

1b. LICENSE GRANT: EDUCATIONAL LICENSE

This paragraph applies to users who purchased an educational license for this product.

The license to use this product is granted to a single user only. All sounds and samples in this product are licensed, not sold, to you by ProjectSAM, for use in NON-COMMERCIAL PRODUCTIONS ONLY, including student projects and teaching purposes. ProjectSAM allows you to use any of the sounds and samples in non-commercial projects without paying any additional license fees. An educational license allows you to install and activate this product on a MAXIMUM OF 2 (TWO) computer systems or samplers, as long as you are the sole user of these systems or samplers.

Above licenses expressly forbid resale or any other distribution method of this product, its sounds or their derivatives, through any means, including but not limited to: mixed, filtered, combined, (re)synthesized or otherwise edited form, through samples, multisamples, wavetables, soundsets, programs or patches in a sampler, game console or any other sample playback device.
